

2023 West Quincy Street Sweepstakes Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING. Void Where Prohibited by law.

- 1. Duration of Sweepstakes:** The West Quincy Street Sweepstakes begins on August 28, 2023 and ends at close of business (9:00pm CDT) on September 25, 2023 (the "Sweepstakes Period").
- 2. Eligibility:** The West Quincy Street Sweepstakes is open to permanent legal residents of the continental United States, 18 years or older, who register at participating Westmont businesses. Employees of the Westmont Chamber of Commerce and Tourism Bureau (WCCTB), participating businesses, WCCTB affiliates, agents, and its advertising and promotion agencies, and their respective immediate family members (spouse, children, parents and siblings) and those living in the same household of each (whether or not related), are not eligible to enter. The West Quincy Street Sweepstakes is void wherever prohibited, and is subject to all federal, state and local laws.
- 3. How to Enter:** In order to enter, each participant must use the required paper entry form provided at either Tapatio Mexican Grill, 11 W. Quincy St., or at Brewed Awakening, 19 W. Quincy St., both are located in Westmont, IL, and deposit the completed form in the designated box. The following information is required for entry: name, telephone number and e-mail address. All Entry Forms must be received no later than close of business on September 25, 2023. Limit one entry per participant per visit at each participating business. Entry Forms become the property of WCCTB and will not be returned. WCCTB is not responsible for lost, late, damaged, misdirected or illegible Entry Forms. Any duplicate entry received will be disqualified automatically. In the event of a dispute over the identity of a potential winner, the potential winner may be required to provide identification sufficient to show that he/she is the person who submitted the entry and is otherwise eligible to win. Any and all late, incomplete or failed submissions will be disqualified.
- 4. Winner Selection/Notification:** The Prize Winners ("Winners") will be selected in a random drawing by WCCTB personnel on or about September 27, 2023, from all eligible entries received. Participants need not be present to win. WCCTB reserves the right to verify that the Winner is qualified and entitled to receive the Prize. The Winners will be notified by phone and email on or about September 27, 2023 between 1:30 p.m. and 7:00 p.m. CDT. If the initial Winner refuses the Prize or is ineligible for any reason to receive the prize, additional random drawings will be done until a Winner is established. Return of any prize notification as non-deliverable will result in disqualification, and an alternate winner being randomly selected.

Each participant agrees to release and hold WCCTB, its employees, officers, directors, representatives or other affiliations harmless from any and all damages, losses, claims and/or liabilities arising out of his/her participation in the West Quincy Street Sweepstakes or resulting from accepting or claiming the Prize awarded hereunder. The West Quincy Street Sweepstakes may be terminated at WCCTB's sole discretion. WCCTB reserves the right, in its sole discretion, to cancel, modify or suspend the West Quincy Street Sweepstakes should viruses, bugs, unauthorized human intervention, technical failures or any other factor beyond WCCTB reasonable control corrupt the administration, security, fairness, integrity or proper operation of the West Quincy Street Sweepstakes. In such event, WCCTB reserves the right to award the Prize at random from among the eligible entries received up to the time of impairment. WCCTB reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the West Quincy Street Sweepstakes or to be acting in violation of these Official Rules or any other Promotion or in an unsportsmanlike or disruptive manner. WCCTB is not responsible for: (1) incorrect or inaccurate transcription of entry information or late, lost, stolen, illegible, incomplete, misdirected or postage-due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (2) technical failures of any kind, including but not limited to the malfunctioning of any telephone, fax, computer, network, hardware or software; (3) unauthorized human intervention in any part of the entry process or the West Quincy Street Sweepstakes; or (4) electronic or human error which may occur in the administration of the West Quincy Street Sweepstakes or the processing of entries.
